KOEI TECMO HOLDINGS CO., LTD. (the Company) has resolved at the board of directors meeting held today to make changes to the representative directors of the Company, also KOEI TECMO GAMES CO., LTD. and KOEI TECMO WAVE CO., LTD., which are major business companies within our group, as well as personnel changes and the appointment of executive candidates. These matters have been decided based on recommendations and proposals from the Company's Nomination and Compensation Committee and have been resolved at the respective board meetings of each companies.

Furthermore, the personnel changes for the Company in June 2025 are scheduled to be formally decided at the 16th Annual General Meeting of Shareholders and the board meeting to be held after the conclusion of the Meeting.

Additionally, at the same board meeting held today, it was resolved to conduct an absorptiontype company split, with KOEI TECMO GAMES CO., LTD. as the splitting company and KOEI TECMO CORPORATE FINANCE CO., LTD. as the successor company, effective April 1, 2025 (tentative).

*To promptly commence operations from the effective date of this absorption-type split, KOEI TECMO CORPORATE FINANCE CO., LTD., which is 100% funded by the Company, was established on February 7, 2025, as a preparatory company for the split.

I. Changes in the Structure of Our Group

Our group aims to become the "World's No.1 Digital Entertainment Company" under the spirit of "Creativity and Contribution." We have been gradually preparing for the transition to the next generation of management through discussions in the Nomination and Compensation Committee. To achieve further growth and profitability for our group, we have decided to implement a new management structure starting from the fiscal year 2025.

1. Regarding "Changes in the Representative Directors of the Company and Its Subsidiaries, Personnel Changes, and Appointment of Executive Candidates"

Starting from the fiscal year 2025, the position of "President" will be designated as the highest responsible officer for business execution, while the "Chairman" will be positioned as the highest responsible officer for management supervision as the chair of the board of directors. This will be able to promote the separation of management supervision and execution, further strengthening corporate governance. The board of directors of the Company will be structured around the "President," who is responsible for business execution, and internal and external non-executive directors who are responsible for management supervision.

Hiroshi Koinuma will assume the role of "President and CEO". Since becoming the representative director and COO of KOEI TECMO GAMES CO., LTD., a major subsidiary, in April 2015, Koinuma has been involved in management as a core member of the next generation of management within our group, and in April 2018, he became the representative director and executive vice president of the Company. Moving forward, he will steer the entire group as the "Representative Director, President and CEO".

Additionally, Keiko Erikawa will become Director and Chairman Emeritus, and Yoichi Erikawa will become representative director and Chairman, focusing on management supervision.

Furthermore, to enhance the supervisory function of management, we will appoint one new outside director and one new outside audit & supervisory.

The business execution responsibilities of the directors, excluding the "President and CEO," will continue to be gradually delegated.

2. Regarding "the Company Split of Subsidiaries"

We will establish KOEI TECMO CORPORATE FINANCE CO., LTD. as a new subsidiary and consolidate the group finance functions within this company. Consequently, we will implement an absorptiontype split of the investment functions of KOEI TECMO GAMES CO., LTD. into KOEI TECMO CORPORATE FINANCE CO., LTD.

This absorption-type split will strengthen governance related to investment functions and achieve optimal cash management.
